MANAGER'S COMMENTS

The FBMKLCI Index up surged by 0.70% MoM to 1,453 in November, the second consecutive month gain. Among the sectors, Utilities, Health Care and Technology were the outperformers, while the Energy and Telecommunication & Media Index were the main laggards.

The S&P Global Malaysia Manufacturing PMI increased to 47.9 in November 2023 from October's eight-month low. The latest reading pointed to the 15th straight month of decline in factory activity, but the softest contraction since April. The Malaysian economy expanded 2.6% on quarter in the 3Q2023, accelerating from a 1.5% growth in 2Q2023. YoY, GDP expanded 3.3%, above market expectations thanks to increase in private consumption, government spending, construction activity and services, offsetting the slow down in net trade.

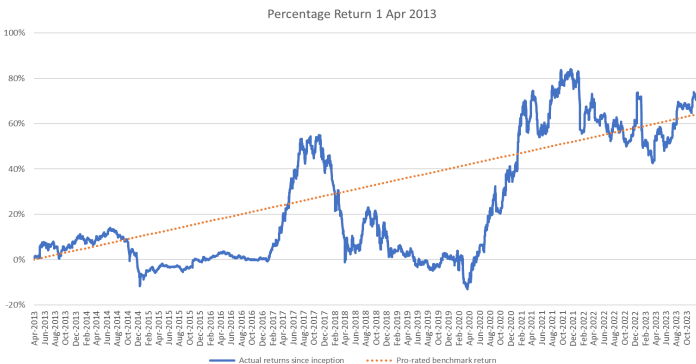
